School, and Broadway Cab signed up. While the paperwork is processed, PDOT is doing some clean up, in order to give us a head start. In addition, they will fix the drain so the water no longer floods the field.

This is another example of how we take back our neighborhood from




neglect and those who disobey the law. My hope is that we can use this to build community and trust.

Tell this has been an interesting month for the neighbors of Sumner. I am so proud of everyone for coming together to support and help shut down a squatter house on 90th & Going.

Our mission is just starting as there are at least 12 vacant houses in the Sumner area. Many of these properties are in the hands of a bank which makes it a little more difficult to evict. However, numerous calls and correspondence to a bank holding onto a property on NE 85th Ave. between Going and Prescott resulted in the property being cleaned out and secured. Hopefully it will be put up for sale in the near future along with the 90th & Going property.

Some of those former squatters have chosen Rocky Butte as their next home creating a safety concern for neighbors. This is an ongoing problem and will be for quite some time. It takes neighbors like ours to safely confront these problems and come together to talk with each other and offer whatever assistance we can.

Thank you's:

- A big thank you to all of the neighbors that donated their time and labor to help clean up the 90th & Going property so that the squatters could not return and set up house again. Thanks also for keeping the police and the media updated on the happenings after the eviction.
- Thank you to Ronda Johnson, SAN Secretary and office manager for CNN, for compiling a list of vacant properties and putting together a book that catalogs concerns and complaints. Ronda offered to find shelter for those at the 90th & Going house but all declined.
- Officer, Bob Boylan, and Crime Prevention Cooperator, Meg Juanez listened to our

complaints at the special crime prevention meeting held August 16 which helped make the above eviction a reality.

 A big thank you goes out to those I am sure I have forgotten to mention. Please know that everyone that assisted made this possible.

Through this process I have met many neighbors I did not know before and, to me, that's what makes a community strong: coming together and supporting each other. New Sumner residents have told me that they chose this area because it feels like it is a nice neighborhood and one they could reside in for years to come.

Neighborhood Watch

Please also note that we are restarting a Neighborhood Watch program. It was active many years ago, and there has been a lot of interest in re-activateing it. Mark Wells, with the City of Portland, will be at the SAN General Meeting on Tuesday, October 18 to provide details and guidelines.

On a brighter note, the Annual Ice Cream Social was held at Helensview on August 13th. Thank you to everyone that came and to the staff members of Helensview that came and provided temporary tattoos for the kids. Portland's Housing Crisis



In June and July 2016, about 545 people attended a series of six inperson open houses hosted by BPS held across the city

s a reminder, the Residential Infill Project Stakeholder Advisory Committee (RIPSAC) seeks to find a solution to the projected 123,000 additional households expected to call Portland "home" by 2035. Keeping in mind that 20% of the additional housing units will be built in single-family dwelling zones and that the Urban Growth Boundary is what it is, Portland needs to create new "rules"

Zoning code amendments will occur through a legislative process in 2017

around the scale and design of new construction as well as address what you can do with the property you currently have. The first step in all of this is to change the zoning code so that limitations are loosened for square footage. Owners of property affected by the proposed changes should receive official notices in the mail.

Public review of the draft proposal ended on August 15th and the committee compiled public feedback into a published summary: www.portlandoregon.gov/bps/article/590169

With this feedback, staff is developing recommendations for City Council. These should be available the week of October 10. City Council will then have a work session on November 1. A public hearing will follow on November 9. Zoning code amendments will occur through a legislative process in 2017. Public Engagement by the Numbers:

- 545 people attended the six in-person open houses
- 8,604 people visited the online open house
- Over 200 people attended additional meetings where staff presented the draft proposal
- 2,375 respondents submitted feedback via the online questionnaire
- 1,562 comments received from questionnaires, comment forms, flip chart notes, emails and letters

Christmas Ships


